Local Cherokee Prove Jew Connection

The Cherokee of Lawrence County, TN, located at #1 Public Square, Lawrenceburg, TN 38464, 931 762 3733, a 501 (c) 3 non-Profit Educational, owns, and operates Cherokee Camp, a 193 acre wilderness camp, 365 days yearly, a free Boy, and Girl Scout Camp, and the Cherokee/David Crockett Museum, and Cultural Center that is free to the public.

During the Cherokee Snowy Moon, Dec. 11th, we received a phone call from our Little Sister, Maryland Two Moons Rising Childress from Lynchburg, VA. She had been helping a friend with his DNA Test Results, and noticed an obscure work printed several times on his Haplogroup, the word Ashkenazi. She did not understand the word but looked it up, and found it to be a scientific DNA term used for the race of Jew. She immediately had Chief Joe Sitting Owl White with her discovery. After the phone conversation we started pulling DNA Files we had in various places that contained DNA results from Family Tree DNA.. All of our DNA Results proved that the Cherokee are Ashkenazi Jews. After making several phone conversations, and email contacts All other tested Cherokee proved to be Ashkenazi Jew, and the Chief had two hits as Levite. All of this information has been sitting in front of our nose for over three years and we did not understand it.

The Ashkenazi Jew Test Results, scientifically proves James Adair's, 1775 research of the Cherokee Culture, and his "23 Arguments as to why the Cherokee are Hebrew", and a "Lost Tribe of Israel", published in London under the title of "A History of the American Indian". Our Museum Gift Shop has a reprint of Adair's Book, "Out of the Flame" for sale for \$30.00, plus \$3.00 S&H. Adair study of the Cherokee is a true masterpiece of a scientific study of a historical culture that is not easy to read, but is considered the most comprehensive record of the Cherokee Customs, and Ceremonies. Unfortunately Adair was under the impression that all native Americans were Hebrew, very little was known of other tribes in 1775, especially the western tribes. Cherokee DNA is totally different from the Asian native American tribes. Cherokee test European. The Cherokee are known as "The Principal People". The Jews are "The Chosen People".

The Ashkenazi Jew Test Results, also serve to prove the "Oldest Story Ever Told" in the Cherokee oral tradition, handed down from generation to generation about The Cherokee Little People being in the Holy Land when Christ was Crucified, and brought back Christ's Teaching to the Cherokee People. The Cherokee Culture is based on Biblical Virtues, and considered a "Civilized Tribe". We have specific names for our "Heavenly Father", "His Holy Son", and "The Holy Spirit". The root words of these names are Hebrew.

We have discovered letters that were written in the 1830's, to, and from Chief John Ross, and Dragging Canoe about the Cherokee being Hebrew, Jews. Chief John Ross wrote back to Dragging Canoe that he personally felt that the Cherokee being Hebrew, or Jews would unfortunately not help in any manner with stopping the planned removal of the Cherokee, "The Trail of Tears". These letters were found in the 2200 plus pages of The John Howard Payne Papers that has never been published, or indexed. We keep a full copy of these special papers in a secure location in our Cherokee Museum. These papers also contain other proof that the Cherokee are Hebrew, and a "Lost Tribe of Israel". It is a highly quoted text that is used by many scholars including Mooney who wrote the "Myths, and Sacred Ceremonies of the Cherokee", and was also convinced that the Cherokee were Hebrew.

We have also found ancient Semitic writing on stone that was found at our Cherokee Camp, and identified as Ogam Conseine, or Ogham Conseine, 3700 B.C. that is on display in the Cherokee Museum Vault for security reasons. This grooved, in stone writing can easily be viewed over the internet in the museum in the middle east. Unfortunately the Celts are trying to claim this language as their one thousand year old writings falsely. The ancient Hebrew writing has been found all over the U.S., and Europe, and is well documented, and is hard, in stone proof, that the Ashkenazi Jews were here a long time ago, and still here in The Cherokee.

Ray, and Penny Pennington have recently identified, and proven that a frequently found artifact in the Southern Native American Mound Era that is described as a hand with an eye in the center is an ancient Jewish symbol known as the hamesh hand, or hamsa hand, The Hand of God. The archeologist unknowingly display the hand up side down. Another ancient Jewish Sacred Symbol has been found locally that is known as "The Sacred Walk".

This gives us ten irrefutable pieces of evidence that The Cherokee are Hebrew, "A Lost Tribe of Israel", with Scientific DNA, James Adairs's 23 Arguments, "The Oldest Story Ever Told", The John Howard Payne Papers, Mooney's, "Myths, and Sacred Formulas of the Cherokee, many of our Countries Founding Fathers stated publically that the Cherokee were a "Lost Tribe of Israel", it is also mentioned in the Movarian Records, and ancient Semitic, Hebrew writing in stone, and the Research of Dr. Daniel Butrick thought to have been lost during the War Between The States.

Most of all we feel that this is a fulfillment of Biblical Prophecy in that The Creator promised us that he would regather his people again in the Last Days. He did not say he would take us back to The Holy Land. We see this regathering by continuous contact with hundreds of small groups of Cherokee all over the U.S. meeting on a regular basis trying to preserve their Cherokee Heritage.

The Churches in the South are full of disenfranchised Cherokee Ashkenazi Jews. Anyone that can remember the old Brush Arbor Services, or has attended this function has experienced a Cherokee Ceremony that goes back to the ancient of times, it is also a celebrated Jewish Ceremony. We have all heard of the "Old Stomping Ground". The Stomp Ground is the most sacred square that Cherokee use in our ceremonies, and preformed ancient Hebrew Rites. We even had an "Ark" that we carried around that same way as "The Ark of The Covenant" was carried, and treated. Adair tells us that it was stolen from the Cherokee in the late 1700's by the Delaware. The Cherokee were also practicing circumcision, before the white man came to our land. In the Cherokee Wedding Ceremony, The Wedding Vase is broken, as is the glass broken in a Jewish Wedding Ceremony.

The Cherokee of Lawrence County, TN has its Petition for State of Tennessee Recognition on file with the Tennessee Commission of Indian Affairs for over 5 years, with no action taken to this date by The Commission. We feel that this is unfair, and now anti-Semitic. Unfortunately the Eastern, and Western Bands of Cherokee are opposed to any State of Tennessee Recognition for any Cherokee organizations, or Tribes.

Our Legal Department feels that their position is in violation of the U.S. Federal Racketeering Laws since they are operating casinos, and is trying to use undue influence outside their tribal areas. Any interference with our

efforts will be met with a complaint to the United States Attorney General. We have no interest in a casino, period. We have been watching their activities in other states, and they have been successful in stopping State Recognition in Arkansas, and North Carolina. We even caught the Western Band of Cherokee lying to the Arkansas Legislature about a Cherokee group seeking State of Arkansas Recognition as a Tribe of Cherokee. We are expecting strong opposition from both groups on our Petition for State of Tennessee Recognition as a Tribe of Cherokee, and have already experienced this opposition within the Tennessee Commission of Indian Affairs itself. We have bad news for them in that the Great State of Tennessee will not tolerate anti-Semitism under any conditions.

The Cherokee of Lawrence County, TN also has a Petition for Federal Recognition on file with the Bureau of Indian affairs in Washington, D.C. According to the Government Accounting Office it will be over forty years before the BIA will even start evaluating our petition, much less, a yes, or no. For this reason we have written 11 letters to Senator Bill Frist, 7 letters to Senator Lamar Alexander, and 7 letters to Congressman Lincoln Davis requesting that they Pass a Bill in Congress granting us Legislative Recognition as a Tribe of Cherokee. This has been successfully accomplished by 9 other tribes in the past. Congressman Lincoln Davis promised us he would introduce a Bill, and told me to personally write the Bill myself. After sending him the Bill he broke his promise because the Bureau of Indian Affairs lied to his aides about our Petition. We also caught the Bureau of Indian Affairs lying to the aides of Senator Frist, Alexander, Fred Thompson, and Congressman Van Hilleary. A Cherokee caught lying is cause for instant banishment forever, Death by shunning, but our Government lies about us on a continuing basis. The Bureau of Indian Affairs has also been caught lying to a Federal Judge, and shredding evidence. This should not be tolerated by our Senators, and Congressmen.

This activity is outrageous, immoral, unethical, and now anti-Semitic. We elect our Senators, and Congressmen to represent all of us, not the Bureau of Indian Affairs. The Lawrence County Mayor, City of Loretto, Aldermen, City of Saint Joseph, TN Commission, Iron City Commission, City of West Point Commission, Lawrence County Board of Education, Lawrence County Chamber of Commerce, Lawrence County Department of Tourism, Middle Tennessee Council of the Boy Scouts of America have all written our Senators, and Congressmen asking them to Pass a Bill granting Legislative Recognition as a Tribe of Cherokee.

They know who we are, and have known us for generation after generation. It seems that our Senators, and Congressman have no ears to hear from their constituents, but maybe they will change their mind now that their position is anti-Semitic. We have sent them a Signature Petition for Recognition signed by over 20,000 people from all 50 States, and 23 Foreign Countries, and plan to send an additional 10,000 in June 2006.

We have also written President George Bush asking him to issue an Executive Order, granting us Official Tribal Recognition 7 times, and included the 10,000 signatures. Unfortunately his White House Staff makes sure he never sees the letter. We are confident that if the President was made aware of what is actually happening, he has the compassion to sign an Executive Order immediately, but he will never know. Our Government sure is out of touch with The People, and their needs.

We are most thankful for all of the words of support, and assistance that we have been blessed with from our State of Tennessee Representative, Dr. Joey Hensley, M.D., and State Senator Doug Jackson. They understand what we are trying to accomplish, and have visited with us in our Cherokee Museum, and corporate offices. Due to the circumstances, we will be calling on them for further assistance. At the least, they both know who we are, and what we are doing.

The Cherokee of Lawrence County, TN are Ashkenazi Jew, and we are continuously denied our Civil, Constitutional, and Religious Rights, by the United States Government, the Bureau of Indian Affairs, and our very own Senators, and Congressman.

The United States has broken every treaty they made to all Native American tribes except that they would take all of their land. This continues today, but you will not see it in the newspapers, or on the TV news. The government keeps this information well hidden from the citizens, and continues to do so.

We all know about "The Holocaust" in Nazi Germany, the Russian Holocaust, and now we can begin by learning about the "Great American Holocaust" of the Ashkenazi Jews. We have estimated that there is over one million disenfranchised Cherokee that are forced by U.S. Law to be a Race that they are not, that of white, and/or Caucasian under penalties of 10 years in prison, and \$250,000.00 Fines. This Genocide of the Cherokee has been going on for over two hundred years, in that we had to hide from the government, or be rounded up on another "Death March" similar to "The Trail of Tears", killed, and relocated to a place worse than Oklahoma. Genocide in any form is illegal in World Law, but perfectly legal in the United States disguised as assimilation. In the past 200 years we can easily estimate that the 7 million, Genocide of Ashkenazi Jews, by death, and by changing their race would be in excess of the 6 million killed in Nazi Germany when we take into consideration the Creek, Seminole, Cherokee, and Senica Iroquois, and their disenfranchised. Leave it up to America to outdo Hitler in getting rid of Jews.

We are continually amazed as to how many disenfranchised Cherokee are members of the Masonic Order, Masons. Our very lives, future, and existence is seriously threatened on a continuous basis. We have been shot at with automatic weapons, physically attacked at our Cherokee Camp, our Cherokee Camp has been destroyed by white people many times with no help from local authorities. Our very lives are at risk. We have been Genocided by the U.S. Government, a form of death. Being forced to be a race one is not, is torture, worse than death. We ask the Masons, "Is there no help for the widows son"? Maybe, the Boy Scouts will come to our rescue.

We would greatly appreciate if our friend, Governor of The Great State of Tennessee, Phil Bredesen, would get actively involved in our State of Tennessee Recognition, and Legislative Recognition with our Senators, and Congressmen. When we were in Nashville for his announcement of Tennessee Native American Indian Day, he told us he was going to have Sequoyah's Cherokee Alphabet engraved in his conference table. Governor Tingle of Hawaii went to Washington, D.C. to get Recognition for her Native Hawaiians.

We have filed a Formal Complaint with The United Nations, Petitions Team, Office of The High Commissioner for Human Rights, United Nations Office at Geneva, 1211 Geneva 10, Switzerland.

We hope, and pray that the United States of America will listen to the United Nations, and put a halt to the Genocide of disenfranchised Cherokee. Unfortunately we found that The UN does not have jurisdiction because The United States will not sign The United Nations Treaty on Human Rights because of the Native American issues.
